**Special Projects Grant Deadline -
March 1st, 2026**

The Oklahoma Ornithological Society's Special Projects awards provide funding to students at any level, faculty researchers, and individuals or civic groups proposing to do work that aligns with our general mission to promote the "observation, study, and conservation" of birds in Oklahoma.

Proposals will be judged by a committee of OOS members who will rank overall merit based on professionalism of presentation, articulation of the question or need the proposal addresses, and significance of the work to Oklahoma ornithology. To apply, prepare a written proposal in MS Word, double-spaced, using 11-pt or larger font, and with a maximum length of 3 pages (not including lit cited and budget). Present the information in the following order:

1. name, institution, and contact information for the applicant
2. title
3. Introduction and justification
4. clear statement of objectives
5. study area and methods description
6. anticipated results
7. literature cited
8. itemized budget of expenses for which the funds will be used

Due to generous donations from the Jerome Westheimer Family Foundation and Janis Blanton, grant awards have increased. The OOS executive board has approved that Special Projects can now award 2-4 grants. Applicants may request support in any amount up to \$2000 (generally between \$500 and \$2000 is preferred). In 2025, OOS awarded three projects totalling \$3100. The submission deadline is March 1st, 2026, with decisions by April 15th, 2026.

Applicants who receive Special Projects funding

for research projects are expected to prepare a manuscript of the work for publication in the Society's journal, the *Bulletin of the Oklahoma Ornithological Society*, and/or deliver a presentation of the work as part of the scientific program at our Fall Annual Meeting, usually held in October. Recipients of funding for non-research projects are expected to summarize their projects in a submission to our newsletter, *The Scissortail*, and are also invited to deliver a presentation at an annual fall meeting.

OOS Winter 2025 Conservation Report

Trump Administration Disincentivizes Wind Energy Development

During its first six months, the Trump Administration has eliminated or restricted all federal wind and solar energy tax credits through Executive Orders and, legislatively, through the One Big Beautiful Bill Act, which was signed into law on July 4, 2025. Legislatively, the existing federal Production Tax Credits and the Investment Tax Credits have been eliminated for all commercial wind and solar energy projects that are not operational by the end of calendar year 2027. The administration also temporarily paused federal permitting for wind projects and canceled approximately \$700 million in federal funding for offshore wind development initiatives, which have created additional barriers for new projects to meet the new tax credit deadlines. Furthermore, the new legislation included restrictions penalizing projects that use components from certain prohibited foreign entities, which has affected supply chains that rely on imported parts for turbine and solar cell production. Like commercial wind energy development itself, these changes have been met with mixed reviews within the environmental and conservation communities. They have been decried by the entities that advocate for renewable energy but applauded by organizations that are concerned about the impact of wind energy development on migratory bird and bat populations, both directly through collision mortalities and indirectly through the degradation of habitat – especially vulnerable prairie habitats, mountain top

habitats, and habitats near wetland complexes and rivers. Currently, some projects are racing to complete within the next 18 months, while many in the planning or early construction phases are being shelved.

Rollercoaster Federal Listing of the Lesser Prairie-Chicken

The status of the Lesser Prairie-Chicken (*Tympanuchus pallidicinctus*) has been dynamic and in a near-constant state of flux since 1997, when it was first proposed for federal listing under the Endangered Species Act (ESA). Between 2000 and 2013, the Lesser Prairie-Chicken was classified as a federal candidate species for possible listing as threatened or endangered. In 2014, the Lesser Prairie-Chicken was listed throughout its range as a threatened species with special ESA rules under section 4(d) of the Act. In 2016, a court order vacated the 2014 federal listing decision, and the U.S. Fish and Wildlife Service formally withdrew the prairie-chicken's threatened status in July of that year. This was quickly followed by a third-party petition to relist the species, and in December of 2022, the federal government listed the Lesser Prairie-Chicken as a threatened species in the northeastern part of its range (Colorado, Kansas, Oklahoma, and the Texas panhandle) and as an endangered species in the southwestern part of its range (New Mexico and extreme western Texas). Once again, the Lesser Prairie-Chicken's status has changed. In May 2025, the Trump Administration initiated a legal review of the 2022 listing decision, asserting that it had foundational defects. In August of this year, a federal district court concurred with the administration's position and vacated the 2022 decision. In the coming months, the U.S. Fish and Wildlife Service is expected to formally withdraw the Lesser Prairie-Chicken's current listed status and is likely to make a new determination on the 2016 listing petition within the next 18 months. Stay tuned.

NOTEWORTHY RECORDS OF BIRDS IN OKLAHOMA:

WINTER 2024-2025 PERIOD

The following is a listing of noteworthy records of birds for the Winter period—December 2024 through February 2025. It incorporates records outside or near limits of expected occurrence delimited by the *DATE GUIDE to the Occurrences of Birds in Oklahoma, Seventh Edition* (Oklahoma Bird Records Committee (OBRC), 2019, Oklahoma Ornithological Society, Norman, OK.). Also included are noteworthy high counts. Exceptional records reviewed and found acceptable by the Oklahoma Bird Records Committee are given in **bold**. Species whose names are followed by an (R) are expected, but RARE in very low frequencies. Underscores for date or locality depict records outside limits specified for the species in the DATE GUIDE. High counts are underscored also. m. ob. = multiple observers.

The winter period in Oklahoma is generally a good time for waterfowl, gulls, and sparrows. While the noteworthy records of geographic rarities, some seasonal, do not focus broadly on population dynamics, the assemblage can depict some patterns of occurrences within season and between years.

There were, at best, weak patterns emerging from this season's observations, except perhaps that there were weak patterns. There was a spurt of Black Scoters with a few double-digit numbers reported. There was also an increasing number of reports of Crested Caracaras, most from the southeastern counties. There was only a modest amount of lingering neotropic migrants. Perhaps of note are the more regular sightings of Palm Warblers during the winter periods, still very rare, but regular in the past few years. And the odd Lesser Goldfinch or four have been noted at several yards extending into northeastern Oklahoma. As last year and the previous year, there were no significant irruptions of boreal or montane species.

Among the rarities, a remarkable occurrence was the presence of up to 8 **White-throated Swifts** (an OBRC Review Species) at Gloss/Glass Mountain SP, dwindling to two on 28 Dec. Several notable gulls included the State's second record of **Slaty-backed Gull**, a primarily Asian species of the north Pacific coasts, including Alaska's northwest coast; it was a first-winter bird distinguished by Scott Loss at Lake Carl Blackwell. A second-winter **Short-billed Gull** (a species primarily of northwestern North America) was discovered briefly in Tulsa County, one of about ten reports in Oklahoma. The flock of **Western Bluebirds** in Washita County was only the second noted east of the 100th meridian. And a **Varied Thrush** in Washington County provided an exceptional occurrence.
